Terms and Conditions of Resonance Violin's instrumental Rental Program

- PURCHASE OPTION AND CREDIT**-During the rental period, customer may apply the rental paid towards the purchase of an instrument from lessor at the current retail price at the time of purchase. **A maximum of three years monthly rental credit (100%)** may be applied for the purchase of a new full size instrument (the credit is not for accessories & repair fees). The new instrument that is purchased must be one of equal or greater value as compared to the current retail price of the instrument that was rented. Credit will accrue only when the account is kept current, the customer may return the rental instrument and purchase a new instrument at any time during the rental period. If a rental instrument is returned and a new instrument is not purchased or if the customer does not wish to purchase a new instrument by the end of the 36 months rental accumulation period, the customer may continue renting the instrument by paying the monthly rental fee, the rental fee will be strictly as rent paid for the use of the instrument and may not be transferred to or combined with any other rental account. **If instrument is returned and new instrument is not purchased, accumulated rental credit is only valid for 30 days.**
- Free instrument maintenance and adjustments**- we will take peg adjustments, open seams and weather causes cracks without charge throughout the rental period, as long as rental payments are current. The renter will be responsible for the rented instrument. If instrument is stolen, lost, damage or destroyed, renter has to reimburse any lose, stolen, damage or destroyed instrument. If the renter selects the **Damage Protection Plan** program, we will take care of all the damages. **However, FREE maintenance and Damage Protection Plan DOES NOT COVER STRING REPLACEMENT.**

3. **The instrument may be returned at any time. DO NOT JUST LEAVE THE INSTRUMENT AT SCHOOL. If you wish to return the instrument to school, Resonance Violins must be notified for pick up, otherwise, you will be held responsible for any lost or damage.** The instrument(s) should return to the shop in person or by mail.
4. **Any instrument or bow can be exchanged for another size at any time and no additional charge.**
5. Terms- Resonance Violins reserves the right to perform credit checks on applicants. **If the rental instrument is to be kept at address other than above, or if the billing address changes, Resonance Violins must be informed of those changes.** This is the responsibility of the signee. Payments **will be made on the fifteenth of the month in advance.** Instrument return is to be **made by before the due date of the month without charge,** Late returns will be charged full monthly rate.
6. PAST DUE ACCOUNT- rental payment made after the due date will be charged \$ 4.00 late fee per month, if payment is made more than 15 days late. These fees will compound monthly at the \$4.00 late fee rate. (1 month-\$4.00; 2 month-\$8.00; 3month-\$12.00 etc) or an amount determined by a periodic rate of 1.5% per month to the unpaid balance.
7. **\$15.00 fee for checks returned for any reason.**
8. **ALL ACCOUNTS THAT ARE SERIOUSLY PAST DUE ARE TURNED OVER TO COLLECTION AGENCIES.** If after 60 days no payments or other arrangement had been made, the instrument will be considered purchased. The balance of the current market value plus all late fees incurred will be due immediately. In addition, the account will be billed for all collection, expenses, court costs and attorney's fee.
